### Footnotes

MY HUCKLEBERRY was never far back, willingly came three wide into lane, took over mid stretch, unchallenged, ridden out to wire. MY JON JOHN allowed to settle early, circled leaving far turn, four wide into stretch, when making bid, no match for winner but clearly best of others. CURLYS DAY well back at the half along inside, finished with a belated stretch rally to gain show spot. AHBUDD chased leader into stretch, gave way in lane. COBRAMATIC hustled to front, set pace for three quarters, faded. SAARMAN failed to menace. FIRST TIME CALLER stalked pace for half, dropped back. COLORADO MAN was never a factor. WERRABRAVECYCLONE was never a threat. MOAB SUNRISE flashed early speed, faded steadily after half.
