I'M TRULYARAINBOW finished full of run mid track to secure third after settling into the three path through the turn. J R'S REQUEST yielded to foes in stretch after setting the pace from outset. ROYALTY IN EXCESS improved placing with late interest. MORE BEER FOR PAUL attended pace as the outer rival of duo into and through the turn, gave way in the stretch. BLATCH'S CONCERN passed tiring foes. RAGGED DESCENT settled into second flight along the two path, had no offering to give in late going. BOLD T. TIMER steadily faded. R DEWEY DELIGHT failed to threaten from a back rated pose. GIMME REIN tired in late stages.
