FLYINGSOFREE was run down by eventual winner in closing strides after leading at the half and at the top of stretch. COVER CHARGER trekked along in the four path and was unable to muster a late rally to run down leader. MY JOHNNY CASH raced mid pack from outset and lacked a rally. BRADLEYSPRIDE shown late interest by improving placement. MY BOOTS BOOGIE gave chase from mid pack early and had no response. CALL ME MR. CASH saved ground to no avail. COWBOY JOE passed tiring foes. PADDY BOY tired late. COLORADO MAN was outrun. SWINGER PROSPECT shown brief speed and tired. BELLA MIA BABY lagged from start.
