**Footnotes**

PULGARCITO broke inwards bothering ARCHIE'S WAY, well placed outside, challenged passing the eighth pole, drew out. TAKEHOME ASOUVENIR had outside speed under pressure, shook his first rival before a quarter had been run, took the inside under pressure on the turn, shook the second rival into the stretch, was taken on by the winner passing the eighth pole, gave way in mid stretch. ARCHIE'S WAY, bothered at the break, checked, advanced inside to force the issue outside on the turn, gave way into the stretch. CASE SETTLED forced the pace inside early, remained well placed inside on the turn, lacked a rally. SERVICE TIME checked at the break, wide early, off the rail on the turn, lacked a rally. The rider aboard ARCHIE'S WAY lodged a claim of foul against the rider of PULGARCITO for interference at the start. PULGARCITO was disqualified and placed third.
