PAYMENT APPROVED dueled inside, responded gamely when asked in the drive, drew out late. QUAKER SHAKER TONY dueled outside, gave his best, couldn't get by, tired late. DEL MAR DRAMA advanced to stalk the duel outside, gained mildly. WINNER IN OVERTIME stalked the duel inside, finished evenly. HI HO CAHILL stalked between horses, steadied in late turn, rallied. MOSEL RIVER saved ground. HIGH TONED stalked off the rail, lacked a rally. MATUCO (ARG) stalked off the rail, inside into the turn, between horses in late turn, lacked a rally. The rider aboard QUAKER SHAKER TONY lodged a claim of foul against the rider of PAYMENT APPROVED for interference in the stretch. There was no change.
