Footnotes

THE MAX stalked a duel off the rail, challenged three-wide between horses into the final turn, dueled into the stretch, was brushed mildly by QUICK WITTED in early stretch when that one came in slightly while taking a short lead, came back out and brushed with that rival nearing the eighth pole while taking back the lead, dueled, drew out from mid stretch. QUICK WITTED stalked widest while rating early, challenged four-wide on the final turn, came over slightly while taking a short lead into the stretch, was brushed mildly by the winner when that one came back to take the lead, dueled, gave way in mid stretch. I TELL U WHAT dueled inside, gave way to the top two in late turn, dug in to save the show. VANILLA SCOOP stalked the duel outside, remained well placed back of a four-horse bid battle through the final turn, finished evenly. BROOKLANDS (GB) trailed to the stretch, rallied belatedly. BOULDER HAT showed little. PASS THE BAR dueled outside, gave way between horses late on the final turn. RUARK stalked the duel inside, faded. The rider aboard QUICK WITTED claimed foul against the rider of THE MAX for interference in early stretch. There was no change.
