**Footnotes**

DOC TAB tracked the leader outside, took over midway through the final turn, opened up into the stretch, drew out. ORCHESTRATION, well placed off the rail, made an outside bid late on the final turn, couldn't stay with the winner, held the place. PELEE ISLAND stalked off the rail, well placed inside on the final turn, rallied evenly. WALL OF FLAME stalked off the rail, well placed on the final turn, finished evenly. FOLLOWYOURDADDY, back early, advanced inside on the final turn. J. MAX saved ground, advanced mildly outside. NO GIMMICK passed tired rivals. KING'S APPROVAL, well placed inside early, faded. NOTORIOUS OUTLAW opened a long lead early, was all done midway through the final turn, gave way.
