SHOWBOATER stalked the duel inside, came off the rail from mid turn to be outside in late turn, rallied to take over in mid stretch, drew out. WOODSHED stalked the duel between horses, rallied between horses. DAILYDBLNOTROUBLE dueled outside, gave way into the stretch. GENERAL BROWN stalked off the rail, advanced widest into the stretch. BEEN THERE BUDDY dueled inside, opened up into the stretch, gave way in mid stretch. WANDO'S APPEAL trailed early, advanced mildly inside. T DRIVE stalked the duel outside, tired in the stretch. PERFECT JUAN stalked wide, faded. The rider aboard WOODSHED lodged a claim of foul against the rider of the winner for interference in mid turn. The rider aboard WANDO'S APPEAL lodged a claim of foul against the rider of WOODSHED for interference in late turn. There were no changes.
