APPLICANT stalked wide, rallied, drifted in in mid stretch, bothering TAKEHOME ASOUVENIR, drew out late. TAKEHOME ASOUVENIR, inside early, advanced between horses, rallied, was bothered in mid stretch, steadied, held the place. MOSEL RIVER trailed to the stretch, rallied wide. KBELLO dueled inside, shook his duel rival after passing the eighth pole, gave his best before giving way. FAMILY HOLIDAY stalked the duel inside, lacked the needed rally. PUTTINONAIRS advanced to force the pace three-wide on the turn, made a bid in late turn, was turned back after passing the eighth pole. QUAKER SHAKER TONY dueled outside, gave way after passing the eighth pole, faded. The rider aboard TAKEHOME ASOUVENIR lodged a claim of foul against the rider of APPLICANT for interference in the stretch. APPLICANT was disqualified and placed second.
