POWER SWEEP LEFT ranged up outside SUPER J R into the far turn with his bid, continued outside that one into the lane and drew clear upper stretch under steady urging. EWING TIGER was in a bit tight early as the winner angled in, settled back off the pace while outside, rallied three to five wide through the far turn into the lane and could not run down the winner. The rider of EWING TIGER lodged a claim of foul alleging interference away from the gate which was not allowed. SUPER J R showed the most early speed to gain position out from the rail in the first turn while on a short lead, continued with the winner to upper stretch then had little left late. HESO saved ground in good position but failed to mount a bid. NASTFASTY saved ground while towards the back of the field, lacked room while behind rivals in the far turn and altered course outward then could not threaten. SMOOTH ALY tracked the pace from three wide to the far turn and tired.
