**Footnotes**

I'VE GOT SPEED angled to the rail soon after the start, raced well back while saving ground, gained inside on the turn, swung out in upper stretch then finished strongly between horses under strong left hand urging to win going away. STRONG IMPACT was well placed in the early going, swung three wide while gaining on the turn, surged to the front in midstretch, lugged in under steady left hand urging in deep stretch and yielded grudgingly while being taken in hand late. Following a stewards inquiry STRONG IMPACT was disqualified from second and placed fifth for interference in deep stretch. PERFECT CASTING raced in midpack for a half, swung five wide at the quarter pole and rallied belatedly. SAINT DAIMON pressed the pace for a half, battled heads apart in upper stretch, steadied a bit a sixteenth out and weakened. WINTHROP HOUSE was reserved for a half, made a strong move along the fence to challenge in midstretch then took up sharply while lacking room in deep stretch. I'M ENTITLED raced just off the pace for a half and steadily tired thereafter. KHAN OF KHANS dueled heads apart to the top of the stretch and gave way. CANT REFUSE was outrun for a half, swung wide at the quarter pole and lacked a late response.
