LISA JEAN allowed to settle under good rating inside, made progress through the turn along the rail under light hand urging, swung for home under a drive, was shifted into the two path nearing the eighth pole, took command at that station, edged clear kept busy to the end while safely holding her nearest rival at bay. DOWNTOWN HOTTIE tracked the front from midpack under a good hold, swung three wide in upper stretch put to a drive, rallied with good energy through the lane unable to reel in the top one while clear for place honors. LADY'S LUNAR LUCK set the pace inside under light pressure while given some rein to work with, was fully engaged by the rider swinging for home along the rail and confronted, was displaced with a furlong to go, battled on to procure the show honors holding well to the end. CENTRINA settled at the back of the pace bidding time, saved ground through the turn, shifted out to the four path nearing the final furlong under a drive, rallied belatedly for the last major share while never threatening the top. WHO IS LADY attended the pace from the two path, was let out nearing the quarter pole, was taken briefly in hand nearing the eighth pole when LISA JEAN came out a step, continued on and was out kicked through the final furlong. I BET TONI KNOWS was pushed along four wide through the turn making some progress on the front through the turn, swung five wide in upper stretch and never threatened. PURE AMOUR tracked the pace inside under a good hold until the quarter pole, was called upon at that station while angling three wide and offered little. GLORY IN MOTION raced three to four wide throughout towards the rear and offered no response. TUTTI VA BENE three wide in close pursuit of the front, weakened after a half.
