Footnotes

ATONED settled just off the pace in good position slightly off the rail, launched a bid in the two path on the turn, gained a slim lead at the quarter pole, shook off ELDAAFER in upper stretch, dug in when challenged in midstretch and turned back ALCOMO under steady right hand urging. ALCOMO (BRZ) was unhurried for a mile, angled in on the far turn, rallied smartly along the rail at the quarter pole, slipped inside the winner to challenge in midstretch, battled into deep stretch and yielded grudgingly. ELDAAFER dropped back after a half, trailed on the far turn, made a strong four wide move to challenge briefly at the quarter pole and steadily tired thereafter. LORD KIPLING chased the leader from outside along the backstretch, lodged a brief move between horses to threaten midway on the turn and faltered at the top of the stretch. DELOSVIENTOS sprinted clear early, set the pace for mile, relinquished the lead while giving way midway on the turn and was eased in the stretch.
