Footnotes

SING MY SONG raced forwardly placed along the outside, moved up under some urging to make a three wide bid nearing the quarter pole, forged to the front at the eighth pole and edged away. SHEZA HEARTBREAKER showed the way along the inside, was let out with several rivals in hot pursuit turning for home, gave up the lead coming to the eighth pole, but held well for the place. RESOUNDINGLY placed three wide at the three-eighths pole, turned for home one path wider and rallied mildly to grab the show. SPEEDY'S GAL raced towards the back of the pack for nearly three-quarters, turned for home placed in the two path and finished willingly en route for the last major share. VICTORY FOR V L TS taken outward at the half mile pole, was driven three wide into the lane and went on to improve position. DOPKE GAL slow to settle, was never a threat. ROGUE urged on the turn, failed to gain ground. HIGH STRIDER three wide departing the backstretch, looped a rival to take over the two path early on the far turn, attempted to bid for the lead coming to the quarter pole but wasn't up to the task. MALIBU MURMUR the last to pop of the starting gate, advanced under a good hold to assume the role of stalker, remained prominently placed for six furlongs and stopped.
