ZA APPROVAL nibbled a bit on the bit before settling down early on the backstretch, was sent over to the rail coming to the half mile pole, didn't stay there for too long, slipping back into the two path a furlong later, waited while stuck in traffic from the five-sixteenths marker to the quarter pole, pilot atop with a snug hold on the reins, espied a narrow gap between the front runners turning for home and made a move towards it, bumped thrice with GRAND RAPPORT, bobbling after the last one, before safely through the seam, picked up the pace noticeably after the exchange of bumps was over and was the first of a still compact group to strike the eighth pole, drifted out erratically during the final sixteenth as the runner up was closing in, but held safely to the wire. VOODOO STORM was slow to settle into stride, gradually closed the gap making his way down the backstretch, remained unhurried from off the inside during the run around the bend, fanned outward turning for home, eventually winding up six wide, the widest of all, came home with good energy to secure second. GRAND RAPPORT well out in the middle of the course in the early stages, tucked into the two path before reaching the half mile pole, sparred from there with FOLLOWMYFOOTSTEPS, was still locked in battle as the tightly-bunched sextet approached the quarter pole, got bumped as the winner attempted to slither his way past in upper stretch, getting knocked sideways, made contact twice more with the same rival before reaching the end of the furlong grounds, continued on with good courage to grab the show. LIGHTHOUSE SOUND placed into the four path coming to the five-sixteenths pole, lacked the necessary stretch response. OUR ENTOURAGE chased the duelers from the three path on the turn before backing away. FOLLOWMYFOOTSTEPS argued for command from the inside until upper stretch, faltered. There was a General Stewards' Inquiry focusing on the stretch run before the result was declared official.
