**Footnotes**

NORTH OCEAN moved up to dispute the pace during the initial stages, contested it three wide and with the rider holding something back in reserve, struck the front by a slim margin prior to turning for home, rider still atop as described before, was well into the furlong grounds before getting asked for some run, drew well off, then finished the final seventy yards geared down. BERNARDO chased three wide, was set down by the five-sixteenths pole, proved no match while securing second. TANGIBLE ASSETS got away very sharply, was guided over towards the inside, vied to maintain control being two wide on the turn, was displaced despite being put to some encouragement, weakened steadily after spinning into the lane into the show slot. VELOCCI off the inside, got angled three wide into the stretch, made no headway. UPROARIOUS GEORGE underwent a ground-saving journey, got asked for some run midway down the backstretch, was under a drive running around the turn, faltered. AWESOME BID three wide entering the bend, was in the four path exiting it, failed to menace. GO TO THE NET lost his footing as the field was sent on its way, brushed with WEST BAY ROAD while stumbling badly immediately afterwards, pulled on the bit as the rider applied a snug grip on the reins, was between foes from the top of the turn until the vicinity of the five-sixteenths pole, tired. WEST BAY ROAD was steadied after making some light contact with GO TO THE NET just out of the starting gate, trailed.
