LOGICAL ORDER reserved while four wide around the far turn, responded well when put to strong left handed pressure in upper stretch, grabbed the lead at the sixteenth pole, then dug in with determination, despite drifting outward several paths in the late stages to prove best. HOOLIGAN'S DELIGHT chased the pacesetter from the outside, challenged that rival for the lead soon after entering the far turn, went past that one, was guided over to the inside once sufficiently clear, was battling for the lead, when forced to check in tight quarters by JACOB'S DREAM at the furlong marker, losing valuable ground and momentum in the process, settled back into a rally a few strides later, then closed with good late energy. N P CAT unhurried while racing off the rail, swung five wide into the stretch, then displayed a good late kick to grab the show. JACOB'S DREAM stalked the pacesetter from the three path, worked his way to a narrow advantage approaching the head of the stretch, came in, despite left handed pressure, impeding HOOLIGAN'S DELIGHT midstretch, swerved out sharply off that rival a couple of jumps later, yielded the lead in the vicinity of the sixteenth pole and weakened slightly thereafter. SUPREME SERENE had a wide trip and came home willingly. OMMADON'S ANSWER lacked the necessary stretch response. ALWAYS FISHIN was no factor. SMARTERALEX saved ground and tired after going three-quarters. MYSTIC ERA broke awkwardly and was outrun. CATHY'S RASCAL set the pace towards the inside for almost six furlongs and stopped. A claim of foul by the rider of HOOLIGAN'S DELIGHT against the rider of the winner alleging interference in the stretch

was not allowed.
