DIAMOND DISTRICT well placed three wide in close pursuit while under reserve, was let out at the top of the lane, engaged the leader through the stretch, dug in resolutely through the final sixteenth battling head to head for a short while before getting the best of his determined rival in the final strides. GOOD LAW set the pace from the two path under light hand urging, was set down at the quarter pole, dug in to preserve his margin with an eighth to go, fought on determinedly through the final furlong before yielding in the final strides while well clear for place honors. SAXOPHONE LEN placed between rivals tracking the front into the turn, lost some position and ground soon after, came under hand urging at the half mile pole to keep pace, swung four wide for home, displayed a mild kick through the lane to just procure the show honors over a late running foe. CRESCENT'S MON reserved well off the pace, came under coaxing to close in at the three-eighths, shifted out nearing the top of the stretch, swung six wide for home, kicked on belatedly for the last major share while just missing for show honors. STONECOLDSTEAMER tracked the front from close range down along the rail, came under a drive at the five-sixteenths, followed the runner up into the lane in the two path, remained in contention until the final furlong before weakening late on. ROARING CONQUEST hesitated at the start and was off a beat slow as a result, chased the front three wide, came under urging at the three-eighths pole and offered little. BEAU DE BEAUPRE raced in midpack under rating tactics down along the inside, was called upon at the quarter pole and offered no response. STUD MUFFIN lunged slightly at the break, chased the front from afar, was put to a prolonged drive at the seven-sixteenths and never menaced.
