KEEP BUSTIN stalked the pacesetter from the outside, ranged up towards that opponent, with the runner up in tow one path farther to the outside, grabbed a narrow lead as the field turned into the stretch, drew off, kept busy to the end. NONNIE CONNIE off the inside, was asked to pick up the pace halfway around the turn, unleashed a three wide run to reach a good striking position by the quarter pole, got called upon, had the rider lose the whip in the vicinity of the three-sixteenths marker, fell back steadily on the top one, held on well enough though to salvage second. PHYSICAL DELIVERY swung four wide into upper stretch, lacked a solid punch. CASTLES BURNING grabbed the advantage shortly after the start, was sent over to the rail, came under assault by each of the first two finishers approaching the quarter pole, readily succumbed and faded. EVAN'S ROCKET rode the rail down the backstretch, tipped into the two path for the start of the run around the bend, failed to make an impact. JAZZINGTON gave chase from near the two path until midway on the turn, was taken over to the rail while backing away, retreated after entering the stretch. MY FAVORITE TWO saved ground early, became choppy-gaited during the final furlong and got eased.
