HOT SPLASH cut the pace, well rated from the inside, got let out heading into the stretch, edged away from the competition during the run through the furlong grounds, dug in with good determination to hold sway. PURELY MAJESTIC put to hand encouragement, unleashed a four wide run on the turn to scurry into contention, continued onward willingly to earn the place. TAPITUDE proceeded her way down the backstretch, with the pilot applying a firm grip on the left rein, departed the backstretch three wide, held on well to secure the show. CLASS ACTION SUIT parked off the winner's outside during the opening half, crept up to increase the pressure early on the turn, remained alongside until the quarter pole, was asked for run but got shaken off in short order, steadily weakened thereafter. EVAN'S ROCKET slipped off the rail at the five-sixteenths pole, came up empty for the stretch run. GRUNGE GIRL ducked over to the rail coming to the quarter pole, tired. KATY'S OFFICE GIRL displayed brief foot, drifted five wide into the stretch while tiring.
