ONE TURN EDDIE set the pace inside, shook loose in upper stretch and drew away while being kept to the task. RUNWEISER was outrun for five furlongs, gained four wide on the turn and rallied mildly. SLIGHT FEVER reserved early, gained three wide on the turn and lacked a late response. NOZZY MINOGUE steadied at the start, raced in hand on the rail to the turn and steadily tired thereafter. CAT IN THE COURT raced up close on the rail and faltered on the turn. REALLY SOMEBODY pressed the pace in the two path for five furlongs and gave way. MOM PROOF trailed then was pulled up in the stretch and vanned off.
