ZIP OF FOOLS was well placed just behind the early leader, moved out nearing the far turn, closed the gap nearing the furlong marker and wore down HOLD THAT PROSPECT under strong encouragement. HOLD THAT PROSPECT sprinted clear on the rail, set a rapid pace along the inside into midstretch, battled into deep stretch and yielded grudgingly. WYATT'S WOMEN settled just off the pace from outside for a half, swung four wide at the quarter pole then closed gradually from outside to dead heat for the place. KISSA MELISSA was outrun to the turn, circled five wide into the stretch and rallied belatedly. HAILEY KEEN raced well back along the inside, angled three wide and lacked a rally. PU DEW up close early along the rail, gave way on the turn.
