STAKES New York Stallion Spectacular Bid S. Black Type - Thoroughbred

FOR THREE YEAR OLDS ELIGIBLE FOR THE NEW YORK STALLION STAKES. By subscription of \$200 due on or before December 1, 2008 with the following eligibility payments: \$1,000 due on or before December 1, 2009. \$5,000 due on or before September 1, 2010; \$350 to pass the entry box, \$400 to start. The purse will be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remaining finishers. 5% of purses won to be awarded to the stallion nominator. 122 lbs. Non-winners of a sweepstake on the turf, or three races allowed 2 lbs.; two races or a race on the turf, 4 lbs.; a race, 6 lbs. (Maiden and claiming races not considered in allowances). A trophy will be presented to the winning owner. (If the Stewards consider it inadvisable to run this race on the turf course, this race will be run at Seven Furlongs on the main track.)

**Footnotes**

DARRIN'S DILEMMA contently stalked the loose pacesetter with the rider applying rating tactics, ranged up towards that opponent nearing the quarter pole, got let out a notch just past the three-sixteenths pole, as the stretch duel commenced, left the eighth pole with the advantage, further increased the lead thereafter, primarily hand urged. BOLD DEED under a firm hold leaving the starting gate, opened up a clear early lead, carved the initial splits, rated along the inside, was put to some light coaxing as the winner made his presence nearing the quarter pole, came to be under much stronger handling a short distance later, failed to keep pace with the top one, relinquishing the lead as the pair headed to the furlong marker, dug in with good determination for the remainder of the race, but had to settle for place honors. WARRIOR UP off the inside, split rivals at the five-sixteenths pole, while commencing to rally, came home willingly enough to grab the show. OUR ELI three wide at the three-eighths pole, got out finished. FREUDS ANA STREAK tracked the pacesetter from the inside, was put to a prolonged drive but could make no headway. ACTLIKEYOUMEANIT angled off the rail coming to the quarter pole, had no kick. SEEK TO DESTROY underwent a three wide pursuit and tired.
