INNOVATOR steadied while being rated along the inside, continued to save ground until angling out at the three-sixteenths, quickly commenced her rally when asked for a response, wore down the leader during the final sixteenth under vigorous handling. SEEING CLEARLY steadied awaiting room, was angled for clearance after entering the stretch, overtook the pacesetter leaving the furlong grounds to gain a brief lead, attempted to turn back the winner's late surge but wasn't up to the task, continued on willingly to garner place honors. CORI'S STAR under a good hold, raced along the outside and finished with good energy to the wire. GABRIELA'S ROSE took the overland route. IVORY STAR vied for the lead along the inside for a half, shook clear approaching the quarter pole, entered the furlong grounds with a comfortable advantage before weakening the final furlong. JR.'S FREEDOM steadied at the break, was outrun early, was taken to the far outside of the course in upper stretch and outfinished tiring rivals. SHOOT THE BUGLER failed to menace. OSCEOLA COUNTY chased three wide for a half and gave way. L D'S GALAXY fought for the lead from the outside for a half and folded. BLUE HILL BAY had a four wide journey and faded after going a half.
