Footnotes

JAPENGO patiently staked the pacesetter, advanced into contention approaching the five-sixteenths pole while still not being asked for his best, responded willingly when given encouragement turning for home, drew along side the leader in upper stretch, forged his way to the front with a furlong remaining and drew away while being kept busy to the finish line. OEDIPUS O'NEAL within striking distance, was roused from the five-sixteenths pole and was along for the place. RACELAND made the lead in short order despite acting a bit rank, showed the way uncontested until approaching the head of the stretch, offered brief resistance when challenged and proceeded to weaken during the final furlong. CORRUPT JUDGE ducked in on the turn and failed to menace. ABSOLUTE RETURN weakly chased the leader during the initial half and gave way. SEPTEMBER HERO trailed.
