Footnotes

NEHANTIC KAT was steadied along the outside while being rated, continued to race under a good hold during the run around the turn, awaited racing room for a brief moment after entering the stretch, was angled to the middle of the course, quickly got into gear and wore down the leader in the final stride. ABSOLUTE HEAVEN set the pace facing only token pressure, sped off in upper stretch to enter the furlong grounds with a sizeable advantage, dug in stubbornly once the winner made her presence felt, and came up just short. MY DEAR ANNIE stumbled badly at the start, was unhurried during the early stages of the event, split rivals after leaving the furlong marker and came home willingly. MY NINA ROSE trailed early, displayed a good late rally. BOXITUP within striking distance until upper stretch, had no rally. CAGEY GIRL was no threat. FLYAWAY PRINCESS steadied early, chased the leader for six furlongs and gave way. SLIPSTONE failed to get involved.
