CAN'T EXPLAIN made the front a few strides out of the starting gate and was sent over towards the rail, carved the pace from there, began to kick clear of the competition during the later stages of the run around the bend, drew off down the lane, crossing the finish line under a brisk hand ride. GIRLUPHIGH (IRE) guided inward after leaving the gate, was taken in hand after tucking into the two path shortly before reaching the end of the backstretch, angled to be three wide midway on the turn,, was already under encouragement coming into the lane, lugged inward after being cross-reined during the initial portion of the stretch drive, lugging inward and bumping with SUNSET TIME, fell back steadily from the top one but went on to win the fight for second. SUNSET TIME grabbed a forward post soon after the start, chased the winner from off the inside, doing so unattached, got carried inward before being bumped by the second place in the vicinity of the three-sixteenths pole, raced on nearly even terms with that opponent to the wire, lost out on second. JANE OF ALL TRADES raced along the outside and was no factor. CHARMING BECKY made a dash and tucked along the rail well before reaching the half mile pole, was initially coaxed along tracking the leader, got put to stronger and stronger handling until set down by the five-sixteenths pole, faltered. BILLBOARD BABE off a beat slowly, was three wide departing the backstretch but in the four path once displaced by the runner at the three-eighths pole, launched a mild middle move on the turn, but was flattening out before reaching the head of the stretch. VALUE IN MOTION was always outrun. AS PER RULING AQ 7-2013 DATED 09/16/14 FROM NYS GAMING COMMISSION,SUNSET TIME IS DISQUALIFIED AND UNPLACED DUE TO POSITIVE TEST.
