REVVED UP prompted the pace from the outside while well in hand, dug in determinedly when roused and drew clear late under a drive. CERTIFIABLY CRAZY set the pace along the inside and dug in gamely inside in the stretch. FOUFA'S WARRIOR was outrun early, saved ground throughout, angled out in upper stretch and finished well. REQUEST FOR PAROLE was rated along outside, raced three wide and lacked a rally. PORFIDO (CHI) was rated along between rivals and had no rally. GUNNING FOR raced close up early, put in a run on the second turn and faded in the stretch. DYNANTONIA was steadied on the first turn, raced four wide on the second turn and tired.
