ZO IMPRESSIVE came away in good order, underwent a three wide pursuit, was let out a notch early on the turn attempting to pick up the pace, displaced WILDCAT'S SMILE as the closest chaser leaving the five-sixteenths pole and was soon set down to stronger handling, made light contact with the runner up as the pair dueled down the stretch, with neither keeping a straight course, dug in with good determination to fend the challenger off and prove best. DISPOSABLEPLEASURE sat reserved from off the inside until the half mile pole, was put to some encouragement at that station and picked up interest, got placed in the four path midpoint on the turn in preparation for the stretch drive, spun as the widest of the front runners into the stretch and took off in earnest after the top one, made slight contact with the winner during the stretch run, the first one occurring in midstretch, followed afterwards about a sixteenth down the road, with each rival seeming to bear some responsibility for each incident, tried hard under a strong drive but couldn't go by. BELIEVE YOU CAN out a step at the start, was pulled off the nearest foe, rubbing shoulders with that one at worse, was lightly urged to secure the pocket, loosely tracked the pacesetter from there, kept to some urging while doing so, idled behind the leader during the later stages of the run around the bend, found room to angle outward and did so entering the stretch, failed to fire when called upon. WILDCAT'S SMILE accompanied CONTESTED from the outside for three-quarters before giving way. CONTESTED moved up to grab the advantage soon after entering the backstretch, pulled slightly on the left side of the bit but otherwise proved ratable, continued on a loosely-contested lead for the opening six furlongs, came under intensified pressure leaving the five-sixteenths pole, was asked for run but readily succumbed. An objection lodged by the rider of DISPOSABLEPLEASURE against the rider of ZO IMPRESSIVE alleging interference in the stretch was not allowed.
