QUONATA was steadied slightly at the start, to avoid contact with KANWICAT, ranged up to the leader four wide during the run around the bend, issued her challenge for the lead turning for home, fought her way to the front with a furlong remaining and drew away from that point under a strong drive. DONNA'S SANDEE forwardly placed in the two path, made a quick move to grab a slim advantage nearing the quarter pole, was immediately confronted by the top one, matched strides with that opponent until midstretch and had to settle for place honors. BELLA BLU saved ground until the eighth pole, angled outward and finished mildly to be along for the show. ED'S PRINCESS reserved along the outside, lacked the needed response when called upon in the lane. OCALA JORGE saved ground throughout. KANWICAT a pace factor three wide for a half, faltered.
