GRANTED TIGER away in good order, stole away to a long, loose lead soon after the start, showed the way from the two path, under a good hold, continued on the front, untested for most of run around the far turn, had the rider glance at the closing twosome, approaching the top of the stretch, responded well once given her cue, spurted off once more to a clear advantage during the ensuing furlong, then held sway under a drive, while drifting outward from the left handed encouragement being given in the late stages. HOT TRIP unhurried three wide, was put to encouragement when HOUSE OF GRACE made her move leaving the half mile, quickly advanced forward, in company with the aforementioned rival, was rebuffed by the top one during the stretch run, but won the battle for place. HOUSE OF GRACE reserved four wide, accelerated upon reaching the second turn, positioned to the outside of the runner up the entire way, reached a good striking position as the abbreviated field turned for home, got outfinished from that point.
