Footnotes

SING MY SONG unhurried during the opening half, picked up interest after departing the backstretch, raced in tandem with the runner up as that pair motored up to the erratic pacesetter during the run around the bend, zoomed by in the four path, still just behind WARM HUGS, was set down as a stretch long duel commenced, battled hard, forged her way to a narrow lead at the eighth pole and refused to give it up. WARM HUGS sat well reserved down the backstretch, was in company with the winner as that twosome overhauled the pacesetter, got hooked up in an intense stretch duel, fought gamely, but had to settle for being second best. SYSTEM READY forwardly placed for three-quarters, proved no match for the first two finishers, while drifting outward in the lane. WICKIE'S FLAME broke slowly, cut the corner under a full drive, failed to reach a contending position. KAISER'S D'LIGHT raced along the outside, folded. PARTY VOW placed under a snug hold refused to rate kindly, split rivals early down the backstretch to assume the front, drifted into the three path and remained out there while cutting the pace, moved inward late on the turn, just as the top pair were taking over, and steadily tired thereafter.
