SEVENTY SIX rode the rail down the backstretch, slipped into the two path a short distance past the half mile pole, got set down a furlong down the road, closed in well during the run through the furlong grounds, altered course with an eighth to go for optimal clearance, chopped away at the TYCOON CAT's lead, wore down that opponent in the final seventy yards and edged away, crossing the wire being hand urged. TYCOON CAT assumed a forward position after the start, patiently stalked the pacesetter making his way down the backstretch, crept up and latched on upon arriving at the half mile pole, kept pace from the two path on the turn under confident handling, poked a head down in front at the end of the bend and got called upon, yielded to the winner well past the sixteenth pole and had to settle for the place. SMOKIN CANDY four wide and asked for run at the midway point on the turn, rallied for the show. GHOSTLY VISION chased three wide, stayed in contention until the furlong marker before backing away. SATURDAY APPEAL made slight contact with EGO FRIENDLY after coming out the gate, showed the way from the inside, under some coaxing by the pilot, had the top one draw abreast by the top of the turn, relinquished readily when put to the test at the quarter pole. M P JOE got away a bit awkwardly, was guided over to the rail coming to the five-sixteenths pole, tired. EGO FRIENDLY bumped lightly with SATURDAY APPEAL soon after the start, raced from off the inside and was no factor. JAMES JINGLE quickly tucked along the rail and was never involved. SKY COLORS three wide entering the turn, was five wide exiting it, folded.
