DRESSED TO WIN pressed a quick pace from outside, shook loose in upper stretch and drew away under a vigorous hand ride. TUTTI VA BENE saved ground to the turn, angled out in midstretch and finished willingly. JUDGE'S PRIDE was hustled up along the rail, set a rapid pace for a half and held well to best the others. BELLA BLU was outrun for a half, swung six wide and rallied mildly. DONNA'S SANDEE raced up close while three wide to the top of the stretch and tired. ROYAL VESSEL was outrun after breaking slowly. JUSTINLINE raced in midpack between horses and tired. LADY VALIANT raced wide while being outrun. SINISTER DEANCE was never close.
