Footnotes

CARBON COUNTY sat patiently pocketed, was eased into the two path midway around the far turn, turned for home and got asked for a response, overtook NELSON AVENUE leaving the furlong marker and kicked clear. NELSON AVENUE contently prompted the leader from off the inside under a good hold from the pilot for nearly three-quarters, issued a serious challenge for command as the field headed into the stretch, emerged from the furlong grounds with none latched on, failed to keep pace with the eventual winner afterwards and got reeled in, continued onward willingly to secure second. SANDYINTHESUN unhurried while racing along the outside, was placed three wide for the start of the stretch drive, rallied mildly to be along for the show. DUAL CITIZEN stalked the front runners from the outside, lacked the needed response. WINDAFULL rated along the inside while vying for command until the quarter pole, weakened in the final furlong. STEPHEN'S REVENGE three wide on the far turn, was no factor. MR. VANTASTIC along the inside, failed to menace. ROARING CONQUEST under a drive going four wide to the three-sixteenths pole, flattened out. GAMBLIN FEVER underwent a three to four wide journey and was outrun. CINCINNATI KID saved ground to no avail. UNGUIDED MISSILE towards the inside, was never in the hunt. IN MY EYES strung out in the three path on the opening bend, remained off the inside throughout, tired after going six furlongs.
