LUBASH patiently watched the runaway leader while sitting a very loose pocket for the opening half, vacated the premises nearing the end of the backstretch and ranged up into contention, doing so under his own power, drew even in the vicinity of the five-sixteenths pole, wasted no time to take over and turned for home with a revved up runner up making his presence felt at this juncture, was in close proximity of the three-sixteenths pole before the pilot finally released a good hold on the reins, saw the margin dwindle down steadily departing the furlong grounds but showed enough determination at the end to prevail. COMPLIANCE OFFICER unhurried as were all until approaching the half mile pole, closed the gap during the run around the far turn, left the five-sixteenths marker from the three path and having already been called upon, displayed a good kick down the course, narrowed in late but got denied by a very resolute foe. STREET GAME left the inside at the half mile pole, proved no match for the top twosome. WESTSIDE CORRAL took the inside route, got angled outward in the vicinity of the five-sixteenths pole, lacked the needed response. MAJESTIC RAFFY three wide until the half mile pole, folded. HANGOVER KID off the inside, failed to menace. MINNIE PUNT three wide around both turns, was outrun. ABILIO made a three wide to grab the early advantage, set the initial splits from well off the hedge uncontested, was slightly closer to it on the second turn, relinquished without putting up much of a fight once confronted by the winner and retreated.
