A supplemental nomination fee of \$1,000 may be made at any point prior to time of entry; \$500 to pass the entry box and an additional \$500 to start. All starters including supplements will be required to pay all fees. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. Three year olds, 119 lbs. Older 123 lbs. Turf Weights. Non-winners of \$60,000 on the turf in 2011 allowed 3 lbs.; a sweepstake on the turf in 2011, 5 lbs.; three races on the turf, 7 lbs. Dirt weights. Non-winners of a sweepstake on the dirt in 2010-11 allowed 3 lbs.; \$30,000 on the dirt in 2010-11 or four races on the dirt, 5 lbs. (Maiden, claiming and starter races not considered in allowances). A trophy will be presented to the winning owner. The New York Racing Association reserves the right to transfer this race to the Main Track. COMPLIANCE OFFICER judiciously saved ground around the opening bend, slipped into the two path early down the backstretch, remained unhurried, began to pick up interest from midpoint on the far turn, came from the four path into the stretch and took off in earnest, drew out to a comfortable advantage during the run through the furlong grounds, safely maintained it under good handling. POCKET COWBOYS three wide around both turns, crept up to the pacesetter leaving the half mile pole, proved no match for the winner in the stretch, but was still second best. MINNIE PUNT sat reserved for nearly three-quarters, was put into the four path midpoint on the far turn, moved up willingly to improve position after being asked for some run, flattened out somewhat after entering the stretch. WRITINGONTHEWALL circled by the competition to take control, tucked along the rail soon after entering the first turn, showed the way loosely contested, felt some pressure by the five-sixteenths pole and soon succumbed. MIDNIGHT BILLY three wide until the quarter pole, angled five wide into upper stretch, had no kick. UNCLE T SEVEN accompanied the pacesetter from the outside for six furlongs before backing away. STRAIGHT STORY tracked the leader from the pocket, faltered. MAKE NOTE trailed.
