CITY ZIP raced with the pace while between rivals three wide, drew clear when set down turning for home, took a clear lead into deep stretch then came out under left handed whipping nearing the wire, bumping and carrying out BURNING ROMA, and prevailed under a drive. BURNING ROMA was taken up as SHOOTER ducked in in front of him leaving the gate, was outrun early, advanced inside on the turn, was steadied while lacking room nearing the stretch, came through on the rail turning for home, altered course to the outside in upper stretch and finished gamely while being bumped and carried out in deep stretch, just missing then was awarded the victory via the disqualification. SCORPION raced close up inside while in hand, put in a run along the rail on the turn and stayed on well to the finish. OMMADON was outrun early, angled out and put in a quick six wide move after leaving the backstretch, continued on even terms to the top of the stretch and faded in the drive. SHOOTER ducked in after the start, was hustled up inside, contested the pace for three quarters and tired. ACCOUNT FOR ME, rated between rivals, was steadied on the backstretch, came wide for the drive and had no rally. HERO'S TRIBUTE stumbled badly at the start, was steadied after the start, raced with the pace while four wide and tired. FREE OF LOVE chased the pace while between rivals and tired after three quarters. UNBRIDLED TIME raced with the pace while five wide and tired after a half mile. Following a stewards' inquiry into the stretch run, CITY ZIP was disqualified from first position and placed second for interference in deep stretch.
