Footnotes

NOKIA raced well-positioned along the rail while under a good hold, launched his move when ready midway on the turn, collared the pacesetter approaching the furlong marker, then protected his advantage under good handling. TRADING RIGHTS reserved early, swung into action with a wide rally on the second turn, finished gamely on the outside to garner the place award. OUTER CIRCLE pursued the early pacesetter along the backstretch, joined the fracas for the lead at the furlong grounds, dug in and held well to the end. ROYAL CONFECTION chased the pace while saving ground, advanced steadily to reach contention at the eighth pole but lacked a further response. BALLY DUFF DANCER set a brisk pace uncontested until midway on the stretch and gave way. DENI MONTANA along the inside, lacked a rally. KING RING had no response. MISS VESUVIO was asked for run on the final turn, offered little. GIVEN TERMS was never a factor while racing wide. BARBARA J. D. a bit sluggish after leaving the starting gate, was never in the hunt. NACAODGOCHES saved ground and tired. WAVERING STYLE stalked the pacesetter while three wide for three furlongs, backed off rapidly, was pulled up on the turn and walked off the track.
