LAWYER JIM settled closer to the inside after entering the backstretch, unleashed a run, starting from the two path at the three-eighths pole to close the gap, maintained the momentum angling sharply four wide for the drive home, outfinished a trio in the late stages to prove best. SNEAKY KITTEN between foes at the top of the far turn, was put encouragement spinning three wide into the stretch, had a good finish to procure the place. ALARMED NDANGEROUS at or near the inside, got asked for a response as three-quarters was being completed, displayed some late foot en route for the show. WESTSIDE CORRAL placed five wide at the three-sixteenth pole, closed in well belatedly. PRETENSION was under a snug hold travelling three wide on the first turn, tucked nearer to the rail upon departing it and contently stalked MIA POPPY from the outside, was asked for run gearing up for a challenge in the furlong grounds, failed to take away the advantage and tired. STATUS OF FORCES coaxed while keeping watch in the pocket, faltered. MIA POPPY was under a snug hold getting quickly guided over to the rail, set the splits being well rated for opening three-quarters, got set down once into upper stretch, yielded in the final furlong and steadily backed away. LEMON PEEL stumbled at the start, raced three to four wide to the quarter pole and gave way.
