LANGSYNE was put to some encouragement right from the get-go, closed in on the front runners travelling in the three path during the run around the bend, turned for home abreast of DOROTHY'S SPIRIT, left that opponent far behind during the ensuing furlong, was still in possession of a healthy margin when finally let up by the rider for the last seventy yards. RAQUEL raced from off the inside, was under a strong drive spinning four wide into the stretch, gained ground steadily on the top one in the final furlong without posing a serious threat. DOROTHY'S SPIRIT rated in the two path while contesting the pace, had just shaken off DELIVERY when confronted by the hard-ridden winner approaching the quarter pole, failed to fire appreciably when called upon and got outfinished. BLAZING ARCHES rode the rail, was put to some stick work by the midway point on the turn, got angled outward to clear a tiring DELIVERY coming into the stretch, had no rally. PASSEPORTA three wide and urged on the turn, folded. TOUCH OF ROYALTY along the inside and urged on the turn, faltered. DELIVERY fought the bit from the left side with good force for much of the way down the backstretch, argued to hold on to a slim advantage from the inside, was put to strong handling and the whip by the three-eighths pole, fell back nonetheless and tired after entering the stretch. NOBODY CARES stumbled badly at the break, bounced back up and was hand urged to rejoin the others, raced three wide on the turn while trailing throughout. AS PER RULING DATED 12/31/12 FROM NYSRWB, BLAZING ARCHES IS DISQUALIFIED AND UNPLACED DUE TO POSITIVE TEST.
