Footnotes

DEPUTY'S CITIZEN three wide, drafted behind DELIGHTFUL VICKY around the turn, tipped off that rival turning for home, was set down after being straightened away, forged to the front with an eighth to go, and edged clear while being kept to the task at hand. JAZZY MOVES reserved along the outside, swerved outward to steer well clear of the ill-fated rival and fallen jockey in the vicinity of the five-sixteenths pole, was steadied momentarily to avoid a rival's heels in upper stretch, got back going shortly afterwards, angled inward and displayed a good kick en route for the place. Z CATS MEOW took the inside route, moved outward to circle past the fallen horse late on turn, losing little if any momentum in the process, then rallied well to earn the show. DELIGHTFUL VICKY chased three wide and weakened during the last eighth. SWEET VENOM stalked the leader from the outside, inherited the lead coming to the quarter pole and tired. AURIC GIRL raced along the outside, was taken outward to avoid the stricken foe, lacked the necessary stretch after being called upon. JUSTINLINE raced three wide and had no rally. POSEY PARK took the inside route, was urged on the turn but backed off. LADY

VALIANT was always outrun. PEA STONE forwardly placed from the start while racing towards the inside, broke down nearing the quarter pole. There was a Stewards' Inquiry focusing on the incident on the turn before the result was declared official.
