KARAKORUM ELEKTRA was unhurried while allowed to settle into stride, picked up the pace nearing the quarter pole, was fanned wide into the lane, settling into the six path at the head of the stretch, gobbled up substantial ground during the run through the furlong grounds, collared the leader just past the sixteenth pole, edged clear and continued on with good energy to preserve the decision. AFFIRMATIF saved ground and had a good finish along the inside to garner place honors. MITIGATION rode the pocket, was forced to be kept on hold nearing the quarter pole, stuck behind rivals, angled into the two path turning for home, but was still mired behind rivals, found an opportunity to swing outward towards freedom coming to the furlong grounds and came home with good late foot to earn show honors. LITTLE NICK underwent a four wide pursuit, fought his front with an eighth to go, before steadily weakening during the final furlong. BEACON HILL ROAD improved position. DUBAI RAINBOW prompted the pace from the outside until upper stretch and gave way. DESERT KEY lacked the necessary stretch response. PULPIT POINT sluggish leaving the starting gate, never threatened. JUST BEN vied for the lead from the inside and faltered. DRIFT KING raced three wide and was through after going a half.
