LINDELL A. C. was grabbed hold and put back on course after coming inward slightly at the break, contested the pace, three wide for most of the way down the backstretch, then two wide on the turn, shook free coming to the quarter pole, responded positively when given his cue in upper stretch, fended off DELEGATED's stretch challenge and edged away. DELEGATED gave chase from the three path and held well to grab the place. COLD PRECISION was taken to the rail nearing the half mile pole, cut the corner into the lane under encouragement, proved no match for the top pair. TOTEMTALE stalked from the two path and folded. DODGING placed four wide at the head of the stretch, had no rally. SAME OLD WISH argued for command near the inside and faltered. LION PRINCE swung five wide into upper stretch, had no offering to render. DEED IT IS raced three wide, was urged on the turn but could make no headway on the front runners.
