Footnotes

UNBRIDLED LOGIC chased three wide on the turn, swung five wide into upper stretch, got there. WIND OF BOSPHORUS set the pace from the two path and held on willingly for the place. JOKING tracked the runner up from the inside, got angled outward shortly after turning for home, flattened out. ALE saved ground and lacked the needed response. LOGAN STREET strung out in the four path at the three-eighths pole, made no impact. HARDROCKER gave chase from the two path on the turn, failed to fire. MAJESTIC JESS (IRE) four wide on the turn, folded. FLOWING MANE raced along the outside and failed to menace. JAMES JINGLE was never in contention. KISS OF THUNDER chased three wide and was through after going six furlongs. COEXIST drifted very wide entering the backstretch, remained well off the rail while trailing throughout and was vanned off.
