Footnotes

GO APPEAL underwent a three wide pursuit, challenged as the widest of three front runners coming into the stretch, wrested away the lead leaving the eighth pole, and edged away. GO CANES GO was rated along the inside, lightly hand urged to maintain interest, was put to the test by another pair coming to the quarter pole and was set down, relinquished in the final furlong but held on well for the place. I WANT YOU TO KNOW saved ground in the early stages, was still down along the rail when asked for a response midway on the turn, commenced a four wide angle a sixteenth later, rallied willingly enough to take the show. NEVADA KID contently stalked the runner up from the two path, was between rivals challenging for the lead at the head of the stretch, backed away late. NORTH OCEAN was quickly guided over to the rail, was rank on the bit rating unkindly during the opening stages, continued along the inside route for six furlongs, lost some ground and momentum getting into the four path during the initial portion of the stretch, lacked a solid offering after finishing the maneuver. WAYWARD SAILOR three to four wide on the turn, was in the six path by the top of the lane, had no rally. DEADICATED DEAL off the inside, lacked the needed response. NEVADA put to a long drive, was four wide at three-eighths pole, failed to get involved. REACHING OUT bobbled at the start, never reached a contending position. YELLOW MOUNTAIN (IRE) along the inside route on the bend, tired.
