TWEET ME established control soon after the start, showed the way on a loosely-contested while being coaxed along from the two path for the opening half, felt intensified pressure coming to the end of the turn and was cut loose, faced still challengers from both sides during the final sixteenth, dug in well to to hold sway. HERE COMES TOMMY took up the chase from the outside, ducked inward and cut corner under a full drive, gained readily throughout the stretch while continuing to hug the rail, came up short. SATURDAY APPEAL underwent a four wide pursuit, was put to strong encouragement by the five-sixteenths pole, closed in on the winner, battled outside another pair in the late stages, held on well to end for the show. WOBURN three wide at the three-eighths pole, was much closer to the inside turning for home under a drive, had little left to offer and tired. RATHSKELLER chased the winner three wide for a half and gave way. SHORTCOMING raced along the outside, was under a drive by midway point on the turn to no avail. IMAGINARY ISLAND saved ground and faltered. BRASSY EGO out broke most of the others at the start, dropped back abruptly after displaying poor action only a few strides later, drifted outward and was allowed by the rider to make it all the way over to the extreme outside, lightly jogged to upper stretch before being pulled up and dismounted, then was subsequently vanned off.
