### Footnotes

HALL OF FLAME took up the chase towards the two path around the turn, had already been put to solid encouragement entering the stretch, was taken hold of briefly approaching the heels of another and deftly altered course to the inside in upper stretch, arrived at the eighth pole as the closest pursuer of the pacesetter, collared that errant rival leaving the sixteenth marker and edged away, both being flashed the whip from the right side and given strong hand urging. AZASECRET quickly attained the advantage and settled into the two path, showed the way on an open lead, lightly coaxed and pulling on the left side of the bit noticeably, entered the stretch still with none latched on and was put to a drive, began to drift outward in deep stretch just as the eventual winner was cutting into the margin readily, got caught with about seventy yards to go but held on well enough to secure second. MADAME PROSECUTOR three wide at the half mile pole, shadowed the wayward runner up outward in the late stages from afar, got outfinished. OUTLAW CODY Z saved ground, was under a drive prior to the five-sixteenths pole, failed to have any impact. EVA LIL near the inside, was asked for some run by the three-eighths pole to no avail. PATTONESQUE chased the leader three wide on the turn, was through after completing a half. COURAGEOUS KAREN displayed brief foot. EDEN QUEEN raced along the outside and trailed throughout.
