

SUCCESSFUL APPEAL argued the pace while along the rail, dug in resolutely when set down turning for home, drew clear in deep stretch then held NOTEASYBEINGREEN safe under a drive. NOTEASYBEINGREEN, urged along outside and wide around the turn, finished gamely from the outside. EXILED GROOM was hustled along on the rail, chased inside and lacked a solid finishing kick. JEANIES ROB contested the pace from the outside, continued gamely into midstretch but weakened in the late stages. HOLMDEL was hard-ridden on the rail early then stopped suddenly on the turn and was eased in the stretch.
