Footnotes

DATTTTS APPEALING placed along the rail briefly was taken back outward soon after entering the turn, gradually moved wider and wider during the turn around the bend, was four wide by head of the stretch when called upon for a response, narrowed the gap from the front runners in rapid fashion to lurk dangerously with an eighth to go, took over for good in the vicinity of the sixteenth pole and drew clear under good handling. CASA TUA four wide departing the backstretch, sat chilly while racing as a team with TIME MARCHES ON from midway on the turn, in sharp contrast with a much energetically-handled opponent, grabbed a narrow advantage when released from the firm hold on the reins in upper stretch, yielded with about a sixteenth to go, held well to secure second. TIME MARCHES ON issued a three wide bid for command approaching the three-eighths pole, with the runner up in tow directly to the outside, went head to head with the aforementioned rival, requiring a drive to keep pace, fell back slightly after turning for home, then weakened steadily in the final furlong. AN ABSOLUTE TEN off the inside, lacked the necessary stretch response. MARY COLE under encouragement turning for home three wide, made no headway on the front runners. PLEASANT PACIFIC sprinted away from the field to establish control, carved the pace from the two path, was put to the test midpoint on the turn and readily succumbed. STARRY ducked in slightly after getting away awkwardly, took the inside route, was asked for some run just past the half mile pole, wilted.
